Objective and investment policy

IS Government Bond Fund is a UCITS mutual fund that invests in bonds issued by The National Treasury, including treasury notes, treasury bonds, treasury bills, or bonds issued by government institutions, such as housing bonds issued by The Housing Financing Fund. The fund may own as much as 10% in liquid assets to meet redemptions or temporarily due to market circumstances. The fund may also invest in financial instruments linked to bonds, i.e. derivatives, but no more than 20% of its total assets.


