

# IS Government Fund

## Objective and investment policy

IS Government Fund is a UCITS mutual fund that invests in bonds issued by The National Treasury of Iceland, including treasury notes, treasury bonds, treasury bills, or bonds issued by government institutions, such as housing bonds issued by The Icelandic Housing Financing Fund. The fund also invests in bank deposits but never more than 50% of the funds total assets. The fund may own liquid assets to meet redemptions or temporarily due to market circumstances. The fund may also invest in financial instruments linked to bonds, i.e. derivatives, but no more than 10% of its total assets, that authorisation applies only to government bonds.

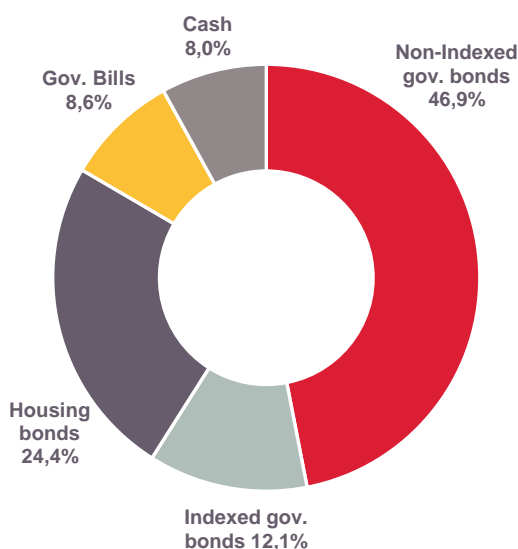

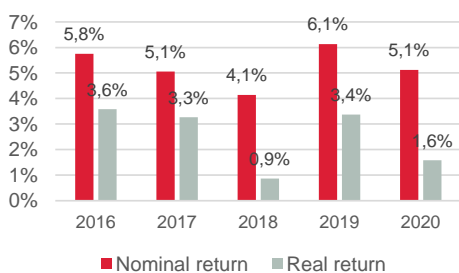

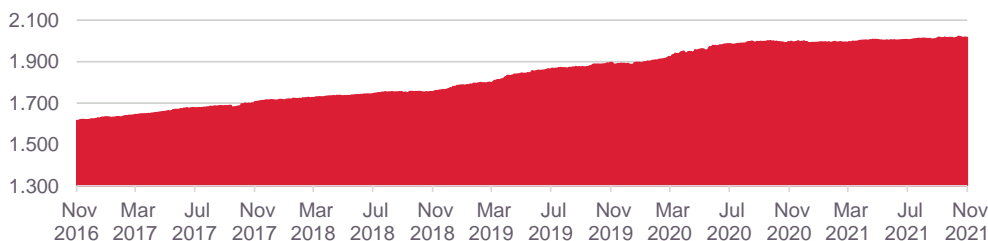
