Objective and investment policy

IS Liquidity Fund is a UCITS mutual fund that invests in deposits, bills and securities issued by financial institutions as well bills and securities issued or guaranteed by the Icelandic Government. The Fund may also invest in municipal securities. The estimated duration of the fund is 1 month to 1 year. High proportion of deposits in the Fund's investment strategy minimizes fluctuations. The fund may own liquid assets to meet redemptions or temporarily due to market circumstances. The fund may also invest in financial instruments linked to bonds, i.e. derivatives, but no more than 10% of its total assets. That authorisation applies only to government bonds.




