

IS Non-Index Fund

Objective and investment policy

IS Non-Index Fund is a non-UCITS investment fund that invests in non-indexed government bonds and non-indexed deposits.

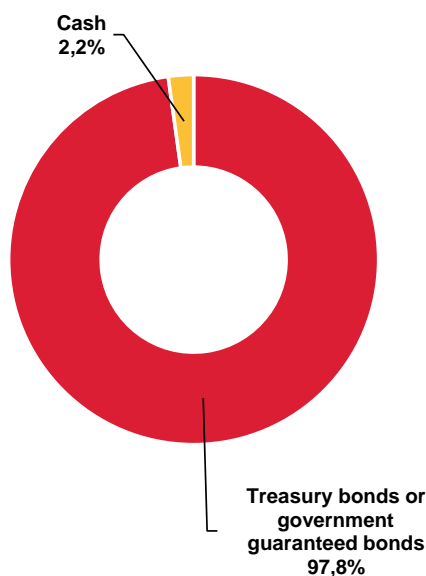
The Fund may invest up to 100% in non-indexed government-guaranteed bonds. The Fund may also invest up to 20% in bank deposits and up to 20% in derivatives to reduce risk. The provisions of article 59 of Act no. 128/2011, excluding paragraph 2 and 5, shall apply to the fund. The fund may also invest in accordance with article 38 of Act 128/2011 regarding secure securities.

The Fund is a non-UCITS fund and its investment authorizations are based on Act no. 128/2011.

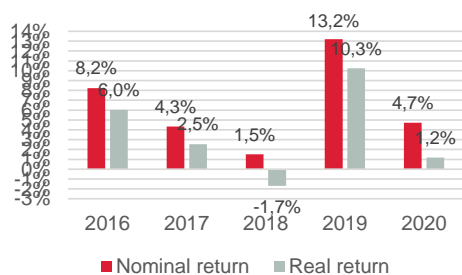

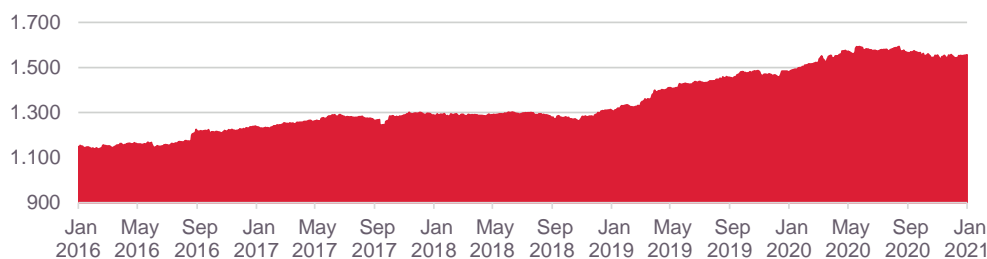
