UPDATE ON OFFERING OF ORDINARY SHARES IN ÍSLANDSBANKI HF.: VOLUME INCREASED TO TOTAL STAKE

Ministry of Finance and Economic Affairs refers to the announcement by the Ministry, dated 13 May 2025, regarding the launch of an offering of existing ordinary shares in Íslandsbanki hf. and the publication of the related prospectus.

Barclays Bank Ireland PLC, Citigroup Global Markets Europe AG, and Kvika banki hf. are acting as Joint Global Co-ordinators and along with ABN AMRO Bank N.V. (in collaboration with ODDO BHF SCA), Arctic Securities AS, Arctica Finance hf., Arion Bank hf., J.P. Morgan SE, Landsbankinn hf. and UBS Europe SE, as Joint Bookrunners in the Offering.

The Ministry today announces that based on significant institutional and unprecedented local demand in the Offering, it has decided to sell all of its Shares in Íslandsbanki hf. by effecting the Volume Increase. The Offer Shares, including the Volume Increase, will therefore constitute a total of 850,000,007 Shares or 45.2% of the issued and outstanding share capital in Íslandsbanki hf. In order to respect the preferential allocation of Book A orders, retail investors shall receive allocations tomorrow morning, 15 May 2025. In the event further stock is available following allocation to retail, those investors participating in Tranche B and C investors shall receive allocation communications on Wednesday morning, May 21, respecting the allocation principles previously laid out in Act no. 80/2024.

The Offer Period in respect of the Offering is expected to close today at 17:00 GMT.

Capitalised terms used but not otherwise defined in this announcement shall have the meanings set out in the Prospectus, which is available on the Bank's website at www.islandsbanki.is and will remain publicly available on the Bank's website for at least 10 years following the date thereof.
